AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Eastmont School District No. 206 from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Student enrollment reporting
- Accounts payable – general disbursements
- Payroll – leave balances and accruals
- Self-insurance for unemployment
- Professional learning expenditures
- Establishment of local revenue and expenditure accounts

INFORMATION ABOUT THE DISTRICT

Eastmont School District No. 206 serves approximately 6,000 students from kindergarten through 12th grade. Located in the City of East Wenatchee in Douglas County, the District has one senior high school, one junior high school, one K-7 school, one intermediate school and five elementary schools.

An elected, five-member Board of Directors governs the District. A Board-appointed Superintendent oversees the District's daily operations as well as its approximately 750 employees. For the 2018-2019 school year, the District operated on an \$83 million budget.
